

# AGREEMENT FOR TEMPORARY HOLDING TANK APPROVAL

INTENDING TO BE LEGALLY BOUND,

and

HIS WIFE, ("OWNERS") AGREE AS FOLLOWS:

1. The Department of Health has issued a Permit for the installation of a sewage disposal system for premises situated on \_\_\_\_\_ Township or Borough, Bucks County, Pennsylvania, being known as Tax Parcel No. \_\_\_\_\_ a copy of which Permit is attached hereto as Exhibit "A", and which Permit was issued on \_\_\_\_\_ .
2. The undersigned OWNERS have fully erected a residential dwelling on the premises, which is ready for occupancy, except for the installation of the sewage disposal system.
3. While the Contractor is ready to install the permitted sewage system immediately, it is the position of the Department of Health that the sewage system cannot be constructed until the ground frost and soil moisture conditions at the site allow for the proper installation of the system, therefore it is impossible for the OWNERS to occupy the premises unless a temporary holding tank permit has been issued by the Department.
4. The OWNERS are in agreement that all necessary precautions should be taken to insure the proper installation of the sewage system as permitted, and are willing to delay the procedures for installation as recommended by the Department of Health, but believe that approval should then be granted to allow them to utilize a holding tank which is part of the system so that they can occupy the premises.
5. In consideration for the allowing of the use of a holding tank, the undersigned OWNERS agree that the sewage disposal system shall be fully installed, and a final approval to cover is issued by the Department on or before July 1, 20\_\_\_\_\_, in accordance with the requirements of the Department of Health as set forth in the Permit as attached; and in the event that there is not full compliance with the installation as required, they will voluntarily vacate the premises on July 1, 20\_\_\_\_\_, and do hereby acknowledge that the permission to occupy the premises shall be automatically terminated if the system has not been fully installed by July 1, 20\_\_\_\_\_ .
6. The undersigned OWNERS further agree that the use of the holding tank shall be in compliance with the Rules and Regulations of the Department of Health, and that the system shall be pumped regularly as required by Department of Health Rules and Regulations.
7. The undersigned hereby agree to be legally bound by the Agreement herein, and acknowledge that the obligation shall be binding upon their successors, assigns, and personal representatives.
