ORDINANCE #9

RATIFYING THE EXECUTION AND DELIVERY, AND APPROVING AND REAPPROVING THE TERMS, OF NESHAMINY INTERCEPTOR SEWER PROJECT SERVICE AGREEMENTS WITH MUNICIPALITIES AND THE BUCKS COUNTY WATER AND SEWER AUTHORITY; SPECIFICALLY RATIFYING AND APPROVING THE COUNTY'S UNDERTAKING UNDER SUCH AGREEMENTS TO MAKE APPROPRIATIONS; AND REPEALING INCONSISTENT RESOLUTIONS AND ORDINANCES.

WHEREAS, the Bucks County Water and Sewer Authority (the "Authority"), which was formed by the County Commissioners under the Municipality Authorities Act of 1945, as amended, for the purpose of undertaking sewerage and water projects as authorized by said Act, has undertaken a project (the "Project") known as the Neshaminy Sewer Project, which contemplates the construction by the Authority of an interceptor sewer capable of receiving sewage from municipalities within its drainage area; and

WHEREAS, the Authority has executed and delivered service agreements (the "Service Agreements") with several municipalities, each of which Service Agreements is in substantially the same form except for the provisions relating to the number of equivalent connection units to be served by the respective municipality's collection facilities and the time of connection of the latter to the Authority's Neshaminy Interceptor sewer; and

WHEREAS, the parties-municipality to the Service Agreements are the Townships of Bensalem, Lower Southampton, Middletown and Northampton and the Boroughs of Hulmeville and Langhorne, the Service Agreement with each municipality being dated February 23, 1965, except for the Agreement with the Borough of Langhorne, which is dated October 28, 1964; and

WHEREAS, the County of Bucks (the "County") is a party to each of the Service Agreements and each of the same has been executed and delivered on behalf of the County by the County Commissioners; and

WHEREAS, in the Service Agreements the County agrees to appropriate such amounts as may be necessary to enable the

Authority to maintain a service charge rate to the municipalities at not in excess of \$28 per year per equivalent residential unit, subject to a limit on such obligation of the County of \$180,000 a year for the years 1967 through 1976, inclusive; and

WHEREAS, the County Commissioners have found, and find, it necessary for the protection of the health, cleanliness, convenience, comfort and safety of the people of the County to support the Project in the manner provided by the Service Agreements;

NOW, THEREFORE, BE IT ENACTED AND ORDAINED, by the Board of County Commissioners of the County of Bucks, Pennsylvania, that:

Section 1: The execution and delivery, on behalf of the County, of each of the six Service Agreements is hereby ratified in all particulars; the acts of the individuals executing, delivering, sealing or attesting each and every of said Agreements on behalf of the County are hereby adopted as acts of the County and fully approved and ratified; and all of the terms and provisions of each of the Service Agreements are hereby approved and re-approved.

Section 2: The undertaking of the County to make appropriations, set forth in Section 11 of each of the Service Agreements, is specifically recognized, ratified and approved.


Section 3: All prior ordinances or resolutions or parts thereof inconsistent herewith are hereby repealed.
